Covid-19 information: You travel at your own risk! Suppliers will, to the extent possible, adhere to the official guidelines in effect at the time of the tour. You are traveling in a group and under certain circumstance it may not be possible to adhere to those recommended guidelines.

In the event of a cancellation of the tour we will try to be as flexible as can be but once funds have been wired abroad we are at the mercy of the suppliers in the event a refund is requested. In that event there may be additional but as yet unknown costs/fees involved.

DO NOT BOOK AIRFARE YET! As a result of the changing Covid-19 situation you should not book air(fare) until you have the green light from us IN WRITING. If you book air without our written release you will be doing so at your own risk!

NOT INCLUDED IN THIS LAND PACKAGE:

Items not listed specifically in the program as included are NOT included.

Examples of items NOT included: airfare, laundry, dry cleaning; alcoholic and non-alcoholic beverages, mineral waters, tea, coffee and meals not mentioned in the trip description; telephone calls and all items of a strictly personal nature.

BAGGAGE:

Most airlines allow 1 piece of checked luggage at no extra charge provided weight and dimensions adhere to airline specifications. All airlines will accept additional luggage for a fee. We suggest you travel light with not more than 1 suitcase and a small carry-on per person. Most airlines have similar rules as to weight and size of checked baggage as well as carry-on bags. In addition the Homeland Security Agency has certain rules. We suggest you check with us before departure for the latest info! Please be aware that overhead storage on motor coaches will not accommodate carry-ons of a large size.

CANCELLATION CHARGES:

The tour price calculation is based on a certain number of participants and guaranteed monetary commitments to the providing suppliers of the travel services. Cancellations are very costly and may occur when there is no time to resell the cancelled space. We therefore highly recommend travel protection insurance. This insurance will cover in case of illness or death of a tour participant and/or an immediate family member. It will, however, NOT cover for change of mind (or fear of war and terrorism).

All cancellations have to be in writing and have to be received by German-American-Travel (german-american-travel@t-online.de), on the appropriate day to be valid.

Due to currency fluctuation the cost of the land package may fluctuate. Therefore the US\$ price shown may change. We will provide you a US\$ price at booking time and will guarantee that price for 10 days during which full payment may be made. Once full payment has been received funds will be transferred to the foreign supplier(s).

If payment has not been received within 10 days the price may change again.
